Directives Governing the Establishment of the Bintang Delapan Scholarship

Article 1 Purpose

The National Taiwan University (NTU or "the University") *Directives Governing the Establishment of the Bintang Delapan Scholarship* ("the Directives") are formulated to establish the Bintang Delapan Scholarship ("the Scholarship"), in order to fulfill the purpose of the Bintang Delapan foundation's donation to support Overseas Chinese Students from Indonesia in pursuing their studies in Taiwan.

Article 2 Application eligibility

The Scholarship is open to undergraduate, master's, and PhD Overseas Chinese Students of NTU who hold Indonesian nationality. Eligible applicants shall have attained a minimum GPA of 3.00 in the previous semester (excluding those who extended their studies) and should have no records of disciplinary actions or punishments.

Article 3 Quota of the Scholarship

The Scholarship has a quota of 4 recipients per academic year, with 2 reserved for undergraduate students and 2 for master's and PhD students.

Article 4 Scholarship amount

The amount of the Scholarship shall be NT\$180,000 in total per academic year. The first recipients shall be granted NT\$60,000 each, and the second recipients shall be granted NT\$30,000 each.

Article 5 Review procedures

Applicants who meet the criteria set out in Article 2 shall be ranked based on their GPA in the previous semester within their respective student status category (undergraduate, master's, or PhD). In cases where applicants have the same GPA, priority shall be given to those with a higher number of course credits. The first recipients shall be those who rank first among their student status category, and the second recipients shall be selected from the top performers among those who rank second or below and can provide a proof of low-to-middle income status.

Article 6 Application Dates and Deadlines

Application dates and deadlines for the Scholarship shall be announced in the spring semester of each academic year.

Article 7 Required documents for the application are as follows:

- 1. The application form
- 2. The Student Status Certification for the current semester
- 3. The academic transcript of the previous semester in Mandarin and their disciplinary records
- 4. For students from a low-to-middle income family, the proof of low-to-middle income status
- Article 8 All matters related to the announcement, application, review, and issuance of the Scholarship shall be handled by the Overseas Students Advising Division of the Office of Students Affairs.
- Article 9 Recipients of the Scholarship found to have falsified or tampered documents for their application shall have their scholarship eligibility revoked and shall be ordered to return the full amount of the Scholarship they have already received. The University shall seek the relevant liabilities against such recipients based on the actual scenario of the offence.
- Article 10 The Directives shall be passed by the Administrative Meeting and then implemented on the date of promulgation.
